If you received \$6.00 per person per day, how much food would you be able to put into your shopping cart? Millions of people across America rely on the Supplemental Nutrition Assistance Program (SNAP) to aid them in feeding their families. It helps but it is not enough. Congress is proposing dangerous cuts to this program that would make it even more challenging for people with limited incomes to keep food in their pantries. <u>Take the SNAP Challenge</u> is an interactive way to learn how people struggle to provide nutritious meals.

Catholic Relief Services

The U.S. Conference of Catholic Bishops (USCCB) and Catholic Relief Services are urging Congress to engage with the Administration as it reviews U.S. foreign aid programs. Most programs have been paused and essential funding that provides lifesaving aid has been stopped. It is normal to review policy but not at the expense of vulnerable communities worldwide. Congress can play a role in keeping these programs running during the review.
